Who is eligible? 10th 11th and 12th grade students

- *10th grade students must be 16 years of age by the time the semester begins.



(CCAP)/ Dual Enrollment provides High School Students 3 times the credits these courses are A-G (16 years and older)



Opportunity to start early college academy program> Students can enroll in 15 combined credits (CCAP cohort and Non CCAP)



Students can earn 25-30 transferable college credits FREE When they graduate from High School

DEFINITIONS OF DUAL ENROLLMENT



- NON-CCAP Dual Enrollment Formerly Known as Concurrent Enrollment:
 - Dual enrollment students are students enrolled in high school who take classes at Victor Valley College on campus or online.
- CCAP -Dual Enrollment Students:
 - Dual Enrollment students are students enrolled in College and Career Access Pathways Partnerships (CCAP) courses through Assembly Bill 288 (AB 288). These proposed sections will be on-site (Excelsior Charter School) and are closed to the general public.

FREQUENT ASKED QUESTIONS



- Who buys the textbooks:
 - Excelsior will pay for textbooks. Students can visit our library first before purchasing a book. At the end of the semester with a valid receipt and with a grade of C or better a full refund will be issued.
- What are the qualifications for instructors teaching sections offered as Dual Enrollment CCAP programs?
 - All instructors for sections offered either as Non-CCAO concurrent enrollment or a CCAP Dual Enrollment partnership will be required to meet minimum qualifications for content areas and fields of study as articulated by the State Chancellor's Office

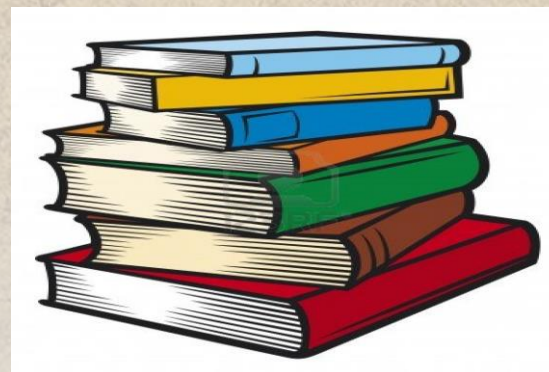
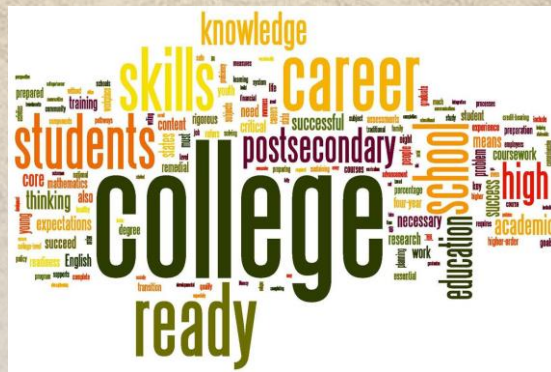
What is level of academic rigor associated with a Dual Enrollment offering CCAP program?

- All syllabi for these courses will adhere to the course outline of record (COR). The expectations for academic rigor and courses quality are exactly the same as for all courses offered through Victor Valley College.
 - * Grades earned are permanent in the college Transcript.

WHO IS ELIGIBLE TO PARTICIPATE?



Students in 10th (16 years of age) 11th and 12th grade with a minimum of a 3.0 GPA and a recommendation from their facilitator, high school principal or counselor are eligible to participate in college academic courses. CCAP and Non-CCAP
