Plan Summary [LCAP Year]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Excelsior Charter School Corona Norco is an accredited and state-funded charter school located in Riverside County serving 7th through 12th grade students. Excelsior’s program is a non-classroom funded, hybrid learning program that includes in-person, virtual and independent study classes, along with concurrent college enrollment and Career Technical Education opportunities.

Once the student is enrolled, he or she is given a class schedule with the appropriate classes and coursework and is also assigned to a Facilitator. The Facilitator serves as an advocate and primary point of contact for the student’s Personal Life Plan and ongoing school needs. The Facilitator is also the person with whom the student and parent or guardian commit to meet with regularly. These meetings are referred to as Facilitator Meetings. The Facilitator meetings are held quarterly. Students have the option of signing up for on-campus classes, virtual classes and independent study courses. On-campus classes courses are offered Tuesday through Friday at all Excelsior school sites. Due to our non-classroom funding model, all students have the option of taking any combination of on-campus classes, virtual classes, independent study or college classes (when academically appropriate). California State Senate Bill 98 requires that all Excelsior students be provided access to weekly synchronous, live instruction. All Excelsior Charter schools employ on-campus classes and live virtual classes to comply with this order.

To gauge academic progress across our system, Excelsior utilizes a common assessment. Unit examinations are conducted quarterly with formative quizzes and tests completed at various intervals identified in the respective course pacing. Examinations are conducted on each campus for four days at the completion of every unit of study. Two versions of each examination are available for completion with the highest grade being utilized for each student’s course credit. All core courses and most elective courses are broken into units that span the entire quarter with daily objectives that are aligned to state standards. Students access the curriculum through the online Canvas Learning Management system. The pacing guide in Canvas identifies what the student should accomplish each day in

order to complete the necessary amount of work within the allotted time period. Parents are separately able to access the curriculum and communicate with the Teacher through Canvas.

Communication and collaboration are critical to the success of our program. We aim to achieve a high level of school connectedness with our students and parents. The use of Facilitators, collaboration focused Learning Management Systems and the inclusion of on-campus classes, virtual classes and dual enrollment make Excelsior’s program unique amongst non-classroom and traditional seat time programs. We believe that Excelsior’s hybrid, differentiated delivery model to be one of the best efforts to meet the unique needs of secondary grade students.



Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Due to the multi-year suspension of the California Assessment of Student Performance and Progress (CAASPP), Excelsior utilizes STAR Renaissance Reading and Math outcomes to inform the pedagogical decisions. The most recently available CAASPP data is from the 2019 school year. Excelsior also uses feedback from Educational Partners and stakeholders to identify academic and support strengths. The programmatic and operational successes are as follows:

- 100% Student STAR Math participation for 1st and 2nd quarters.
- 100% Student STAR Reading participation for 1st and 2nd quarters.
- 100% Teaching and Teaching Support staff STAR Reading and STAR Math participation.
- Development of Formal Observation process to identify teaching and learning strengths and areas of growth.
- Acquisition and implementation of Hovercam technology to provide synchronous live instruction for students who were previously on Independent Study for English and Math courses at all grade levels.
- Implementation of Character Strong SEL efforts to support student mental health and wellness in all classroom and student learning lab settings.
- Provided mobile hotspots to support remote learning for McKinney-Vento and Socio-Economically Disadvantaged students.
- Added Hovercam Learning technology equipment in all English and Math classes to expand synchronous live access to all students choosing remote learning or staying home due to COVID-19 quarantine requirements.
- Provided additional laptops to all staff to support remote instruction.
- Wellness spaces added to support student and staff mental health.
- No year over year learning loss observed for STAR Reading or STAR Math 2020/2021 school year.

Reflections: Identified Need

Due to the 2018/29 authorization of Excelsior Corona-Norco and the suspension of the 2019/2020 and 2020/2021 CAASPP testing, the California Dashboard has no results for the school. Excelsior Corona-Norco utilizes the results from our local assessments (Renaissance STAR Reading and Math) performance to highlight the need for significant improvement in:

- English Language Arts performance
- Mathematics performance
- College/Career Readiness
- English Learner progress

In the four areas identified above performance gaps exists between the performance of All Students and the performance of Foster Youth, Low Income and English Learners. The development of new English and Math curriculum along with retooled assessments paired with Teacher professional development are the primary strategies to address these performance gaps along with the addition of specific support staff.

The goals and actions identified in the LCAP and Excelsior’s operational processes is influenced by the feedback from our educational partners. The feedback received highlighted the need to increase synchronous support in English and Mathematics. The feedback also highlighted the necessity to improve the support for our English Learners, English Learner families, expanded dual enrollment and CTE opportunities at smaller campuses. Due to feedback from educational partners Excelsior Corona-Norco has identified the following goals:

Goal 1: Students will increase their college and career readiness and overall performance in Mathematics as measured by the CAASPP, by enhancing fluency in problem solving, interpreting concepts and procedures, communicating reasoning, modeling and data analysis.

Goal 2: Students will increase their college and career readiness and overall performance in English as measured by the CAASPP, by enhancing fluency in reading, writing, research/inquiry, speaking and listening.

Goal 3: Students will increase their College and Career Readiness through Proficient or Advanced achievement on the CAASPP, dual enrollment, A-G completion or CTE certification as measured by the CA Dashboard.

Goal 4: English Learner students will increase their academic and social readiness levels as measured by ELPAC and the CA Dashboard Indicators for EL progress.

Goal 5: Increase teacher and administrator teaching and learning efficacy through professional development.

Goal 6: Increase Social Emotional Learning support for students and staff.

This goal was developed to increase the math readiness for Excelsior Corona students. Excelsior Corona student performance is calculated through an examination of each student’s previous CAASPP performance. To close the achievement gaps amplified goals were created to support the identified subgroups.

The most recent California Dashboard data shows Excelsior Charter School performance as 94 points below the standard. The state average is 33.5 points below the standard.

Goal Analysis for 2022/23

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Excelsior conducted a grade level, phased in return to in-person instruction for the 2021-22 school year after being on a state mandated quarantine. While students within our system were able to return to in-person instruction for the 2021-22 school year after attending school through distance learning in the 2020-21 school year, consistent learning was difficult to achieve due to the ongoing COVID pandemic related interruptions. Students and teachers who tested positive, had a significant exposure, or showed symptoms of COVID, were required

to observe a 10-day quarantine at home. This created gaps in student/staff attendance and learning. Students were moved from their in-person instruction and placed on short term independent study or virtual instruction to continue their learning. This forced interruption had a negative impact on learning. With these developments and interruptions to teaching and learning, it was difficult to implement many of the actions for 2021-22. Substantive differences between planned actions and actual implementation were as follows:

1. Teacher professional development was disrupted as in-person observations were limited to 5-minute intervals to lessen the likelihood of COVID-19 exposure or transfer.
2. Separation of Zoom and In-person instruction was delayed to Fall 2022/23 due to staffing shortages brought on by the limited number of teachers available during the pandemic period.

Excelsior hired additional certificated staff so that each campus has CORE subject credentialed teachers and added counselor positions that will focus on delivering direct instruction to students and providing SEL and career and college readiness support to our students, exceeding the 25:1 ratio required for a non-classroom-based charter school.

Instructional Aides/English Language Development Aides – Performance gaps identified demonstrate the need for additional Instructional Aides and English Language Development Aides for students to access the instruction and academic language in order to achieve mastery.

Substitute Teachers – Due to the ongoing and continual teacher shortage substitute teachers were needed. The teacher shortage extended to the necessity to raise the daily rate of Substitute Teachers from \$185 to \$275 per day.

An explanation of how effective the specific actions were in making progress toward the goal.

Returning to in-person instruction was well received by student and parents. Overall enrollment increased due to Excelsior Corona's robust online support and in-person safety and sanitation efforts. Excelsior Corona did not administer the CAASPP during Spring 2021, but did administer the STAR assessments. These assessments included the ELA and Math tests, which are used to predict CAASPP performance. These results, which compared Fall of 2020 to Fall of 2021 did show a decline in student growth which was expected due to

difficulties encountered during distance learning with included high levels of mental health stress and anxiety. Additional support in supplemental instruction, support and professional development has an increased budget for 2022-23 to provide additional opportunities to address the learning gaps and accelerate learning across all campuses.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Reflections from prior practice necessitated the need to have all core curriculum redesigned by an outside vendor (Canvas). The following Math curriculum is being developed to improve the instruction and assessment base materials:

- Math 7, Math 8, Algebra 1, Algebra 2, Geometry

Feedback and reflection of the desired outcomes necessitated adding the following positions:

- 3 added Counselor positions
- English Learner Programs Administrator additional duty
- 2 Area Director positions to support teaching and learning.
- 2 additional Spanish Teachers

Additionally:

- Professional Learning Community professional development
- Professional development for dually identified students (Special Education & English Learners).

- The social distancing requirement restricted the ELA Coach’s ability to do in-person observations and prolonged site visits during the fall semester. Restated, by Spring of 2022 the ELA Coach was able to conduct group professional development and in-person observations at all school sites.

Excelsior conducted a grade level, phased in return to in-person instruction for the 2021-22 school year after being on a state mandated quarantine. Returning to in-person instruction was well received by students and parents. Overall enrollment increased due to Excelsior’s robust online support and in-person safety and sanitation efforts. Excelsior did not administer the CAASPP during Spring 2021, but did administer the STAR assessments. These assessments included the ELA and Math tests, which are used to predict CAASPP performance. These results, which compared Fall of 2020 to Fall of 2021 did show a decline in student growth which was expected due to difficulties encountered during distance learning with included high levels of mental health stress and anxiety. Additional support in supplemental instruction, support and professional development has an increased budget for 2022-23 to provide additional opportunities to address the learning gaps and accelerate learning across all campuses.

Excelsior’s goal to expand the by school site Career Technical Education offerings was greatly impacted by the inability to provide in-person instruction until the last month of the 2020/21 school year. The expansion was also hindered by the social distancing requirements and high levels of absenteeism during the Fall 2021/22 semester. During this time period Excelsior Corona is working to expand the CTE offerings by leveraging the vocational education offerings available from Norco College.

Further, the community colleges aligned with Excelsior Corona also paused or restricted course offerings due to COVID-19 Administrative decisions delaying college course completion for dually enrolled Excelsior Corona students. (Chaffey College and Norco College).

Excelsior Corona also added a part time classified facilitator position to work directly with students and parents for a consistent and careful review of the students’ educational progress and professional life plans.

Excelsior conducted a grade level, phased in return to in-person instruction for the 2021-22 school year after being on a state mandated quarantine. While students within our system were able to return to in-person instruction for the 2021-22 school year after attending school through distance learning in the 2020-21 school year, consistent learning was difficult to achieve due to the ongoing COVID pandemic related interruptions. Students and teachers who tested positive, had a significant exposure, or showed symptoms of COVID, were required to observe a 10-day quarantine at home. This created gaps in student/staff attendance and learning. Students were moved from their in-person instruction and placed on short term independent study or virtual instruction to continue their learning. This forced interruption had a

negative impact on learning. With these developments and interruptions to teaching and learning, it was difficult to implement many of the actions for 2021-22. Substantive differences between planned actions and actual implementation were as follows:

5. Teacher professional development was disrupted as in-person observations were limited to 5-minute intervals to lessen the likelihood of COVID-19 exposure or transfer.
6. Separation of Zoom and In-person instruction was delayed to Fall 2022/23 due to staffing shortages brought on by the limited number of teachers available during the pandemic period.
7. Support for English Learner students was conducted weekly through live Zoom sessions led by Bilingual Excelsior Administration and Staff.
8. Support for English Learner families was conducted bi-weekly using the Zoom platform to provide additional assistance and clarifications in both English and Spanish.
9. Excelsior's planned action to develop the English Learner Programs Administrator (ELPA) position was developed. The ELPA's goals were modified to ensure that all Excelsior site Administration was fully trained to enable better support for English Learners in classroom instruction, socialization and parent support.

Excelsior hired additional certificated staff so that each campus has core subject credentialed teachers and added a counselor position that will focus on delivering direct instruction to students and providing SEL and college and career readiness support to our students, exceeding the 25:1 ratio required for a non-classroom-based charter school. The additional staffing will allow Excelsior to offer intensive support to our students that are most in need.

An explanation of how effective the specific actions were in making progress toward the goal.

The English Learner Programs Administrator was highly effective in providing Administrator training across all school sites and Central Office Administration. Excelsior now has improved translation services; English Learner Parent supports and integrated English Learner classroom support. Excelsior continues to improve our efforts for designated support for English Learners. The following pedagogical elements have been modified to improve our support for instructional leadership when targeting support for English Learners:

- English Learner strategies added to DigiCoach formal observation checklists.
- English Learner professional development added to all monthly leadership meetings.

- English Learner staff professional development added to quarterly planning process calendar.
- ELPAC participation is 100%.
- District English Learner Advisory Committee (DELAC) development

Excelsior Corona students participated in an intramural athletics' program and other social events to expand their interaction with other Excelsior campuses and outside programs.

Excelsior Corona is in the early stages of development for PBIS/MTSS. Full implementation of PBIS is necessary to understand the correlation between our SEL related actions and a decrease in student discipline and increase in positive student behaviors. Excelsior Corona experienced an increase in Gaggle alerts with 100% follow up within a 24-hour period or less.

Excelsior Corona also experienced a very slight increase in low level disciplinary incidents. It is noted that PBIS wasn't fully implemented. Additional training has been provided to encourage the full implementation of PBIS along with additional SEL supports.

The COVID-19 related disruptions identified above restricted our first semester efforts to add new CTE programs as the focus was largely on adhering to the social distancing/sanitation mandates and addressing student, staff and parent anxiety. It is our intent to continue to develop a broader offering of CTE programs and leverage the use of collegiate vocational education as the student enrollment continues to grow.

Reflections from prior practice necessitated the need to employ the community college's vocational education offerings to meet our CTE goal without abandoning our efforts to increase the number of on-campus CTE offerings. To best execute the utilization of college courses to meet our CTE goal we had to make the following adjustments:

- Conduct student interest survey to determine the level of interest for college based vocational education.
- Modify student schedules to allow them to align with high school and on-campus college attendance.
- Conduct informational sessions with parents to explain how the program will be executed.

The utilization of Victor Valley College to satisfy expanding our CTE efforts serves as a template for Excelsior Corona.

Feedback from foster youth students and their families has provided data that has determined foster youth students need ongoing support to improve the school connectedness. Expected Outcome(s): Excelsior Corona will look to increase the number of students participating in and completing CTE Pathways. Excelsior Corona will locally monitor the enrollment and also completion of CTE pathways. Excelsior Corona will also monitor the number of students graduating “prepared” on the College and Career Indicator as well as the Graduation Rate indicator on the California Dashboard to monitor the ongoing effectiveness of this action in increasing the number of unduplicated students who are enrolling in and completing CTE Pathways. Excelsior Corona will continue to monitor the percentage of students graduating “prepared” on the College and Career Dashboard Indicator.

 - This amount is the total of the Estimated Actual Percentage of Improved Services column
- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)

- This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8)
